Union of India & Ors. before the Hon'ble Calcutta High Court and outcome/implementation of OA No. 371/2011 filed by Shri Anoop Kumar Srivastava & Ors. Vs. UOI & Ors. before the Hon'ble CAT, PB, New Delhi.

4. The promotion of aforesaid officers to the grade of Superintendent is purely on ad-hoc basis. It does not confer on them any right to claim regular promotion or any other service benefits and they can be reverted to their original post anytime without assigning reason. They will not form part of the regular strength of Superintendents and will not be entitled to seniority in the grade of Superintendent.
