2. The aforesaid promotion order is being issued on *in-situ* basis and shall be effective from the date of assumption of charge. A copy of the assumption of charge should be endorsed to this office also.

3. All promoted officers are directed to must assume charge latest by 12.09.2022, without fail.

4. If any officer is not interested in accepting the promotion he may make a written request that he may not be promoted and action in terms of DoPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 shall be initiated and all consequences arising as a result of non acceptance of promotion shall follow.

5. The controlling officer shall ensure that if any of the officers whose name figures in this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post and this should be immediately reported to this office. Further, if any officer is undergoing any penalty, he/she should be allowed to assume the charge of the post only after the expiry of the currency of the penalty and this should be reported to this office.

6. The pay and allowances of the newly promoted officers will be granted only from the date of assumption of charge. Newly promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of F.R.-22(I)(a)(i) as per DoPT OM No. 13/02/2017-Estt.(Pay-I) dated 27.07.2017 within one month from the date of assumption of charge, to have the pay fixed under this rule from the date of such promotion or to have the pay fixed from the date of accrual of next in crement in the scale of the pay in lower grade. However, if the officers who have already been granted financial up-gradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme prior to promotion, their entitlement may be decided as per extant instructions.

7. The promotion shall be subject to outcome of case of **Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors.** (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011) pending in the Hon'ble Supreme Court and any other relevant case pending in any Tribunal/High Court or in the Hon'ble Supreme Court of India and / or any review measures undertaken by this Department in pursuance of any decision of Tribunal/Court and/or any direction of the Ministry pursuant to any judicial order.
