The said transfers will be effected from the date of joining in the CCA, Lucknow and will be governed by all the terms and conditions as laid down in the letter F. No. 22015/23/2011-Ad.IIIA dated 27.10.2011 of the Board along with following terms and conditions:-

- 1. If any transferee has been promoted to higher post by his current parent Zone, his ICT transfer will only be considered subject to his reversion to the post of Tax Assistant in his parent Zone.
- 2. The transferees will be placed below all the officers appointed regularly in the grade of Tax Assistant on the date of his appointment on transfer basis in terms of para 3.5 of DOP&T's O.M. dated 03.07.1986 as amended. In other words such a transferee will be junior to those regularly appointed officers prior to his date of joining in this Zone. However, such transferred officer will retain his eligibility of the parent Commissionerate /Zone for his promotion to the next higher grade, etc.
- 3. The transferees will not be considered for promotion in his old parent Zone/Commissionerate.
- 4. The transferees will not be entitled to any Joining Time and Transfer Travelling Allowance.
- 5. The transferees are liable to be posted anywhere within the jurisdiction of Cadre Control Authority Lucknow Zone.
- 6. If, there is any vigilance case pending/contemplated against any of the above transferees then prior to his relieving, details must be sent to this office.
- 7. The Service Book and Personal File of the transferee may be directly sent to the Commissionerate/ Formations where they will be subsequently posted.
- 8. The transferees may be relieved at an early date but not later than 29.07.2022. Transferees so relieved should report to this office on next working day of his relieving as they are not entitled to any joining time.
