No.- 0522-2233063****ESTABLISHMENT ORDER NO. I/A/CCSC/28/2022**

On specific direction of CBEC vide letter dated 24.10.2016 and interim orders of Hon'ble CAT Allahabad Bench and Principal Bench New Delhi in the matter of Anuj Gupta / Azim Ahmed and Saulesh Kumar respectively, a review DPC exercise was held on 19.02.2021 whereby the DPCs held during the period 13.12.2002 to 27.11.2017 in respect of promotions made into the grade of Inspector, were reviewed. The three successive DPCs held on the same date i.e. on 19.02.2021 recommended demotion of 704 inspectors to the grade of ministerial cadre followed by re-promotions of 645 inspectors. Remaining officers could not be re-promoted for the reasons of retirement/VRS/death/dismissal/Inter Commissionerate Transfer etc. Accordingly, three Establishment Orders, No. I/A/CCSC/11/2021, I/A/CCSC/12/2021 and I/A/CCSC/13/2021 all dated 19.02.2021 were issued.

2. In the combined case of Civil Appeal Nos. 2485-2490 of 2010 in case of Dhole Govind Sahebrao & others vs. Union of India & others, Civil Appeal Nos. 2491-2503 of 2010 in case of Union of India & others vs. A. Karunanithi, Civil Appeal No. 2577 of 2010 in case of Union of India and others vs. Awadhesh Kumar & others and Civil Appeal No. 10386 of 2013 in case of Union of India & others vs. Issac Varghese & others, **the Hon'ble Supreme Court vide judgment dated 26.03.2015, ordered to give effect to Rules 4 and 5 of the Tax Assistant Recruitment Rules, 2003 and Senior Tax Assistant Recruitment Rules, 2003 respectively, without any further delay.** Further, in Civil Appeal Nos. 1970-1975 of 2009 in case of D. Raghu and Others vs. R. Basaveswarudu and others, **vide direction no. 23 the Hon'ble Supreme Court also ordered for consideration of seniority in the grade of Data Entry Operator Grade 'B' based on Rule 5 of the Senior Tax Assistant Recruitment Rules, 2003.**

3. Subsequent to exercise of review DPC dated 19.02.2021 in the grade of Inspector, representations were received from erstwhile Date Entry Operators (DEOs) Grade that while re-promoting the officers DEOs have been at disadvantage for the reason of not properly considering their inter se seniority fixations while re-designating as STA/TA in terms of STA RRs 2003 & TA RRs 2003. A very few representations were also received from some retired officers stating that they have been left out of the whole exercise of re-assignment of promotion due to which pay fixation issue is not resolved causing financial problems to them. It was found that the representations received in this regard were maintainable and liable for redressal action.

4. After careful examination of whole issue and **in compliance to the Hon'ble Supreme Court's directives mentioned in para 2 above**, a considered decision was taken to review the DPCs held on 19.02.2021 in terms of part VI of DoPT OM dated 10.04.1989, with a view to rationalize the order of re-promotion/re-assignment of promotions, taking into account the rationalized relative seniority among feeder ministerial cadre viz Old TA/STA/Steno Grade- I, II & III/EA. Before proceeding to review DPCs held on 19.02.2021, earlier DPCs in respect of promotions to the grade of TA (Old)/STA/EA/Steno Grade-I have also been reviewed to figure out a rationalized combined consideration zone.

5. The DPC/review DPC held on 24.03.2022 recommended re-assignment of promotions from ministerial grade to the grade of Inspector with reference to Establishment Orders No. I/A/CCSC/12/2021 and I/A/CCSC/13/2021 both dated 19.02.2021, in the light of reviewed/re-assigned seniority among the feeder ministerial cadres viz TA(Old)/STA/EA/ Steno Grade-I, II & III. The recommendations of the DPCs/Review DPCs have been approved by the Competent Authority, accordingly, revised promotions on **Ad-hoc basis** against regular vacancy of direct recruit quota into the grade of Inspector with reference to Establishment Orders No. I/A/CCSC/12/2021 and I/A/CCSC/13/2021, both dated 19.02.2021, is ordered as under. The undermentioned officers promoted on *Ad-hoc* basis will not form part of the regular strength of Inspectors and will be shown separately and they will not be entitled to seniority in the grade of Inspector. On promotion they will retain their present place of posting.
