**ESTABLISHMENT ORDER NO. I/A/CCSC/20/2022**

On specific direction of CBEC vide letter dated 24.10.2016 and interim orders of Hon'ble CAT Allahabad Bench and Principal Bench New Delhi in the matter of Anuj Gupta / Azim Ahmed and Saulesh Kumar respectively, a review DPC exercise was held on 19.02.2021 whereby the DPCs held during the period 13.12.2002 to 27.11.2017 in respect of promotions made into the grade of Inspector, were reviewed and consequent to this three Establishment Orders were issued. This review DPC has had cascading effect on the feeder grades of Inspector, down the line i.e. on Tax Assistant (Old)/Senior Tax Assistant/ Executive Assistant/ Stenographer etc.

2. Subsequent to above exercise of review DPC in Inspector grade, it is found that vide DPCs/review DPCs held in the grade of Tax Assistant (Old) during the period 15.04.2002 to 11.09.2012 events of vacancies taken for promotion in the grade of Tax Assistant (Old) for the vacancy years 2000-01 onwards have been partially or wholly shifted to different vacancy years.

3. After careful examination of whole issue, a considered decision was taken to review the DPCs held for promotion in Tax Assistant (Old) grade for the vacancy years 2000-01 onwards, with a view to rationalize the promotions, with respect to correct vacancies, due to changed scenario after Review DPC dated 19.02.2021 held in the grade of Inspector.

4. The review DPC held on 24.03.2022 recommended re-assignment of promotions from Upper Division Clerk to the grade of Tax Assistant (Old). The recommendations of the DPCs/Review DPCs have been approved by the Competent Authority. Accordingly, re-assignment of promotions on regular basis into the grade of Tax Assistant (Old) are hereby ordered as under:-
