ESTABLISHMENT ORDER NO. I/A/CCSC/25/2022

After merger of erstwhile Stenographer Grade-I & erstwhile Stenographer Grade-II and their re-designation as Stenographer Grade-I, and re-designation of erstwhile Stenographer Grade-III as Stenographer Grade-II in terms of CBEC letter dated 22.12.2010, and for implementation of CBEC/CBIC directions regarding applicability of Recruitment Rules of Stenographer Grade-I, DPCs in the grade of Stenographer Grade-I for the vacancy years 2013-14, 2014-15, 2015-16 have been reviewed on 24.03.2022. DPCs for promotion in the grade of Stenographer Grade-I upto the vacancy year 2022 were also held simultaneously.

2. The recommendations of the Review DPC/DPC have been approved by the Competent Authority. Accordingly, re-assignment of promotion/ fresh promotions on regular basis from Stenographer Grade-II to the grade of Stenographer Grade-I in Pay Band-2 (Rs.9300-34800 and Grade Pay Rs.4200) of 6th Pay Commission / Level-6 in the pay matrix (Rs.35,400-1,12,400) of 7th Pay Commission are hereby ordered as under:-

3. The aforesaid promotion order is being issued on *in-situ* basis. Promotions in respect of officers mentioned at Sr. No. 29 to 32 above will be effective from the date of assumption of charge. A copy of the assumption of charge should be endorsed to this office also.

- 4. The freshly promoted officers must assume charge latest by 308.04.2022, failing which it will be construed that he/she is not interested in accepting the promotion. Failure to assume charge shall be treated as refusal to accept the promotion offered to the officer and action in terms of DoPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 shall be initiated and all consequences arising as a result of non acceptance of promotion shall follow.
 - 5. The controlling officer shall ensure that if any officer whose name figures in the freshly promoted list of this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post and this should be immediately reported to this office. Further, if any officer is undergoing any penalty, he/she should be allowed to assume the charge of the post only after the expiry of the currency of the penalty and this should be reported to this office.
 - 6. The pay and allowances of the promoted officers will be granted only from the date of effect of promotion as per extant instructions.
 - 7. The pay and allowances of the promoted officers will be granted only from the date of effect of promotion. Newly promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of F.R.-22(I)(a)(i) as per DoPT OM No. 13/02/2017-Estt.(Pay-I) dated 27.07.2017 within one month from the date of issuance of this order. However, if the officers who have already been granted financial up-gradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme prior to promotion, their entitlement may be decided as per extant instructions.
 - 8. The re-assignment of promotion/promotion is subject to outcome of case of **Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors.** (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011) pending in the Hon'ble Supreme Court and any other relevant case pending in any Tribunal/High Court or in the Hon'ble Supreme Court of India and / or any review measures undertaken by this Department in pursuance of any decision of Tribunal/Court and/or any direction of the Ministry pursuant to any judicial order.
