7. All the officers except officers mentioned in para 2 & 3 above must be relieved by 10th June 2022 to join their new place of posting.

8. Relieving & joining status may be intimated to this office.

9. All representations received regarding transfer and posting in the grade of Superintendent stand disposed off. No fresh representation shall be considered unless officer joins his/her new place of posting.

10. While issuing transfer order within Commissionerate, the concerned Pr. Commissioner/Commissioner shall strictly follow the Zonal Transfer Policy 2020 and deviation, if any, should have prior approval of the Pr. Chief Commissioner of CGST & Central Excise Zone, Lucknow.
