2. The aforesaid promotion order is being issued on *in-situ* basis and will be effective from the date of assumption of charge. A copy of the assumption of charge should be endorsed to this office also.

3. The promoted officers must assume charge latest by 22.03.2024, failing which it will be construed that he is not interested in accepting the promotion. Failure to assume charge shall be treated as refusal to accept the promotion offered to the officer and action in terms of DoPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 shall be initiated and all consequences arising as a result of non acceptance of promotion shall follow.

4. The controlling officer shall ensure that if any of the officers whose name figures in this order is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post and this should be immediately reported to this office. Further, if any officer is undergoing any penalty, he should be allowed to assume the <sup>1/1929537/2024</sup>charge of the post only after the expiry of the currency of the penalty and this should be reported to this office.

5. The pay and allowances of the newly promoted officers will be granted only from the date of assumption of charge.

6. The promotion shall be subject to outcome of case of **Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors.** (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011) pending in the Hon'ble Supreme Court and any other relevant case pending in any Tribunal/High Court or in the Hon'ble Supreme Court of India and / or any review measures undertaken by this Department in pursuance of any decision of Tribunal/Court and/or any direction of the Ministry pursuant to any judicial order.
