Establishment Order No. I/A/CCSC/14/2024

In terms of Estt. Order No. 40/2024 dated 31.05.2024 issued by the Additional Commissioner, Office of the Principal Chief Commissioner of GST & Central Excise, Tamilnadu & Puducherry, Chennai Zone vide F.No. GCCO/CCA/MISC/1/2023-CCAESTT-O/o Pr CC-CGST-ZONE-CHENNAI/I/2115551/2024, Shri Raghvendra Pratap Singh, Inspector, Coimbatore Audit Commissionerate has been transferred and posted on loan basis to CGST & CEx Zone, Lucknow with immediate effect for a period of two years.
