Establishment Order No.I/A/CCSC/31/2024

In pursuance of the order dated 03.08.2012 passed by the Hon'ble CAT, Chandigarh Bench in OA No.338/PB/2012 and in compliance of CBIC instruction dated 03.08.2017 and 31.12.2019 issued under F.No.C-18012/19/2012-Ad.IIB, an Establishment Order No.69/2020 dated 28.02.2020 was issued by CCA-Lucknow whereby <u>22 'similarly situated persons'</u> of CCA-Lucknow were promoted as Superintendent on notional basis w.e.f. the date mentioned against their names in the said establishment order dated 28.02.2020.

- 2. While carrying out the said exercise, the name of Shri Rajendra Sharan Tiwari, Superintendent (now Retd.) (DOB-17.05.1956) was considered but he was not granted benefit of the final order dated 03.08.2012 passed by CAT Chandigarh Bench in OA No.338/PB/2012 because the service-particulars of the said officer were not verified by any of the formations.
- 3. Now, the service-particulars of Shri Rajendra Sharan Tiwari, Superintendent (now Retd.) (DOB-17.05.1956) have been verified by CGST-Dehradun.
- 4. Accordingly, the following officer is hereby promoted as Superintendent on notional basis w.e.f. the date mentioned against his name in the following table on the basis of the length of service rendered by him in the grade of Inspector (i.e. from the date of their initial appointment to the post of Inspector) in Customs and Central Excise Department.

- On promotion, the inter-se seniority of the said officer shall be re-fixed as per the extant rules because the service rendered by the said officer prior to Inter Zonal Transfer, can only be counted for the purpose of eligibility in the up-gradation.
- 5.2 The officer will also be eligible for consequential benefits such as payment of arrears of pay in the grade of Superintendent.
