## ESTABLISHMENT ORDER NO.I/A/CCSC/05/2024 DATED:-25.01.2024

One Time Relaxation (OTR) in qualifying service for promotion to the post of Executive Assistant from the post of Tax Assistant for filling up vacancies of Executive Assistant during the vacancy year 2022, was granted by Central Government vide letter F.No.A.12018/01/2012.AD.III.B dated 29.12.2022 read with subsequent letters dated 17.01.2023, 25.01.2023 and 15.05.2023.

- 2. For implementing the said OTR, a DPC was convened on 29.12.2023 which recommended promotion of 44 Tax Assistants to the post of Executive Assistants effective from date of assumption of charge.
- 3. In order to correct the inadvertent reporting discrepancies, a Review DPC was convened on 25.01.2024 to review the DPC proceedings of 29.12.2023.
- 4. Consequent to approval of recommendations of Review DPC dated 25.01.2024 by the competent authority:-
  - (a) Shri Vikas Kumar (D.O.B-06.04.1987) is hereby promoted to the grade of Executive Assistant on regular basis with notional effect from the date of promotion of his junior. His seniority is fixed below Shri Banwari Kannaujia promoted vide Establishment Order No.I/A/CCSC/33/2023 dated 30.12.2023.
  - (b) Shri Vismay Srivastava (D.O.B-02.09.1991) is reverted back to his feeder Cadre (i.e., Tax Assistant) with immediate effect.

6. The pay and allowances of the newly promoted officer will be granted

from the date of assumption of charge. Promoted officer is entitled to

exercise the option for fixation of pay on promotion in terms of F.R.-22(1)(a)

(i) as per DOPT OM No.13/02/2017-Estt.(Pay-I) dated 27.07.2017 within

one month from the effective date of this order. However, no arrears shall be

payable till the date of actual joining in the grade of Executive Assistant.

7. The controlling officer shall ensure that if the promoted officer is

under suspension/or facing any charge sheet /or prosecution / or penalty,

he should not be allowed to join the post of Executive Assistant and this fact

should be reported to this office immediately.

8. The newly promoted officer must assume charge latest by 01.02.2024

in his respective present formation(s) failing which it will be construed that

he is not interested in accepting the promotion. Controlling officer is

requested to send the joining report by 12.02.2024 to Cadre Control Branch,

CGST & Central Excise, Lucknow Zone.
