### CORRIGENDUM TO

#### ESTABLISHMENT ORDER NO. I/A/CCSC/30/2025 DATED: 19.11.2025

Vide Establishment Order No.I/A/CCSC/30/2025 dated 19.11.2025, formations were assigned to 322 newly promoted officers on a temporary basis. Out of 322 officers, the formations of only 14 officers (S.No. 6, 38, 76, 84, 92, 122, 163, 194, 217, 241, 491, 493, 510 & 522) were changed due to administrative exigencies.

2. The field formations have *inter alia* reported that, out of said 14 officers, 02 officers (mentioned at Sr.No.6 and 510) have foregone their promotions. Whereas, few of the remaining 12 officers have represented against their transfer from their present place of posting (i.e., CGST-Kanpur or Audit-Kanpur) to CGST-Agra.

3. After due consideration, the competent authority has decided to amend the Para 4.3 of the Establishment Order I/A/CCSC/30/2025 dated 19.11.2025. The said Para 4.3 will now be read as under:-

*" 4.3 The 11 officers mentioned at S.No.38, 76, 84, 92, 122, 163, 194, 241, 491, 493 & 522 will be stand relieved from their present place of posting w.e.f. 01.12.2025 (A/N). The controlling officers are directed to not relieve them prior to 01.12.2025. The officer mentioned at Sr.No.217 will be stand relieved from his present place of posting w.e.f.31.03.2026 (A/N). The controlling officers are directed to not relieve him prior to 31.03.2026."*

4. With issuance of this corrigendum, all the representations received so far regarding Establishment Order I/A/CCSC/30/2025 dated 19.11.2025 are disposed off.
